Objective / content

This course aims at an introduction to social sciences in the marine realm for PhD students that have their main focus in the natural sciences. It starts with an overview and then goes into exemplary topics in different disciplines. Topics and examples are chosen from the marine realm (e.g. fisheries issues, marine protected areas management).

Participants shall learn about key concepts and typical approaches in the social sciences and also about key commonalities and differences to natural science approaches. This is intended to further mutual understanding and facilitate future collaboration in inter- and transdisciplinary research and development projects.
